Cancellations

Cancellation of registration within 1 month

- Full refund.

Cancellation of registration after 1 month up to 6 months

- Refund of registration fee less £50 cancellation fee.

Cancellations between 6 months and no later than 3 months before confirmed EPA date

- The IMI will refund value of a full EPA retest.

Cancellation of registration within 3 months of confirmed EPA date

- No refund.

External Quality Assurer Charges

Any charges from the External Quality Assurance Organisation to register candidates, carry out initial approval and low risk monitoring of training providers will be covered within the candidate registration fees.

If the Training Provider is subsequently identified as medium or high risk by the External Quality Assurance Organisation, any visits and associated charges over and above previously described will be charged to the Training Provider.

Technical Observation Option A

This is the preferred option under the current Assessment Plan. If this plan changes, implications and any amendments to services and prices will need to be agreed between both Parties.

Option A:

The Training Provider will provide:

- Apprentices, Maximum 9 Per EPA event.
- Facilities, workshop, classroom etc.
- Resources, vehicles, tools etc.
- Assessment staff, ratio of 3:1 Apprentice.

The IMI will provide:

- Technical observer, ratio of 1:3 assessment staff.
