## IMI PROFESSIONAL STANDARDS

The professional standards set a benchmark for industry professionals & focus on professional behaviours with the consumer or customer in mind

They have three core strands and these are:



**CONDUCT AND ETHICS** – Behaviours that include honesty, courtesy, lawfulness, integrity & placing customer satisfaction first



**PROFESSIONAL COMPETENCE** – Behaviours directly associated with the skills and context of your job role



**CONTINUING PROFESSIONAL DEVELOPMENT (CPD)** – Behaviours related to your own personal professional development
